


## Rules and Regulations of the “Quests with the 1<sup>st</sup> Cadre Company” Badge

### I. General Provisions

1. As part of the “Quests – Explorer Expeditions” Programme, the *Map of Passions Foundation* shall hereby establish the “Quests with the 1<sup>st</sup> Cadre Company” Badge, hereinafter referred to as “the Badge”.
2. The purpose of the Badge shall be to disseminate historical knowledge of the 1914 March of the 1<sup>st</sup> Cadre Company from Cracow to Kielce, including any respective locations and individuals.
3. Any individual taking action to earn the Badge shall be required to observe the letter of Polish law, and standards commonly accepted in Poland. Any individual taking action to earn the Badge shall be required to respect natural and cultural heritage resources.
4. The first 500 Badges shall be issued free of charge as part of the “*Explorer Expeditions Following the 1<sup>st</sup> Cadre Company*” project funded from the *POLAND INDEPENDENT (NIEPODLEGŁA)* Multiannual Programme for the Years 2017-2022, within the framework of the “*Poland Independent*” Governmental Grant Programme.

### II. Badge Classes. Terms and Conditions of Earning the Badge.

1. The Badge shall be available to individuals 6 years of age or older.
2. Actions to earn the Badge shall be taken by completing Quests included in the “*Following the 1<sup>st</sup> Cadre Company*” group.
3. The Badge shall be established and available in Basic class only.
4. Any individual with a User Account registered on the [www.questy.org.pl](http://www.questy.org.pl) website and capable of proving in a manner duly described herein that he/she has completed a specific number of Quests available on the [www.questy.org.pl](http://www.questy.org.pl) website and the “*Quests – Explorer Expeditions*” (“*Following the 1<sup>st</sup> Cadre Company*” group) mobile app, and met all additional conditions required for a specific Badge class, shall have the right to apply for the Badge. Primary Quest completion proof shall comprise [www.questy.org.pl](http://www.questy.org.pl) data. While an individual taking action to earn the Badge will not be obliged to keep a personal record or Explorer Passport, he/she may choose to do so for personal convenience.
5. Users are encouraged to earn the Badge concurrently with taking action to earn other Quest and tourist & sightseeing badges.
6. Detailed terms and conditions for earning the Badge, respective Badge classes included, have been listed below:

### III. Badge Awarding Procedure

1. Once the User has met all Rules and Regulations requirements, the fact of such User having earned the Badge shall be confirmed by relevant notification, and by a system-generated code lodged on the User's Account on the [www.questy.org.pl](http://www.questy.org.pl) website.
2. Once the Badge award notification has been issued, any individual concerned shall have the right to acquire the Badge of the respective class. Badges shall be distributed by the *Map of Passions* Foundation office. Information regarding the Badge collecting procedure shall be displayed on the respective User Account on the [www.questy.org.pl](http://www.questy.org.pl) website.

### IV. Final Provisions

1. The *Map of Passions* Foundation shall hereby reserve the right to modify the Rules and Regulations for the Badge without any obligation to specify reasons for such modification(s). Any resultant changes shall come into force as of the date of their publication in Rules and Regulations.
2. Any doubts potentially arising with regard to interpreting these Rules and Regulations shall be resolved by the "*Quests with the 1<sup>st</sup> Cadre Company*" Badge Team at the *Map of Passions* Foundation.
